Lieutenant Howe offered to bring the licenses over to the establishments in the morning as he would be in City Hall. The Clerk agreed to reach out to each of the licensees.

\*Note for file: Some licenses still had outstanding paperwork/fees that required attention, and the Clerk's Office is awaiting compliance to complete this step.

Ms. Bohart stated that she was attending the meeting as it was helpful to listen to the dialogue and look for a chance to help any businesses, especially those that had been closed since March. She also was hopeful that as many businesses as possible would apply for one of the available mini grants that the City had through HUD or the Redevelopment Authority and that businesses could apply for both without being penalized to do so..

Commissioner Sarefield inquired as to the amount that had already been awarded. Ms. Bohart stated that there has been over \$400K to date directed in the Community – although not all of it was directly for those that the License Commissioner served. She mentioned that the hospitality industry had been particularly impacted by the COVID virus.

Commissioner Sarefield asked if Ms. Bohart would share any reports she might have regarding the awards in order to help the Commission understand how it was distributed. Ms. Bohart agreed to do so, and also noted that certain groups, such as social clubs, were not eligible to receive a grant under the current guidelines.

The meeting adjourned at 6:49 PM
