- \* All payments are on a Monthly basis, paid one month in advance, and non-refundable. Billing continues until your hangtag is returned to the Treasurer/Collectors office. Customers are responsible for paying bills and any late fee charges in full. All past due invoices will be subject to a \$5.00 Monthly late fee plus interest. \*\*Initials \_\_\_\_\_
- \* The City of Fitchburg, its agents and employees, are not responsible for any loss or damage to any motor vehicle or its contents, by FIRE, THEFT, COLLISION or any other cause, or for ANYTHING CONTAINED in a vehicle. The holder hereby releases the City of Fitchburg, and its agents and employees from any and all responsibilities in connection with the holder, the holder's motor vehicle and/or the holder's other personal property.
